POWER OF TRUSTEES

5. To pay all costs, charges and expenses incidental to the management, administration and execution of the objectives and powers herein contained.
6. To open and maintain account or accounts for the Trust in any scheduled bank or banks for the purpose of keeping the moneys and to operate on the same or to authorise anyone or more to operate upon them.
7. To accept, in cash or kind, donations, gifts, grants, contributions (as Corpus or otherwise) and to collect interest and other income of the Trust for being utilised for furtherance of the aims and objectives of the Trust.
8. To purchase or to take on lease lands, buildings and other immovable or movable properties in the name of the Trust.
9. To invest, dispose of, transfer and otherwise deal with monies, assets and properties, for the time being, of the Trust in such manner as the law permits and proper to do in carrying out objects of the Trust.
10. To pay all expenses preliminary or incidental to the formation of the Trust and its registration and for management and administration for the same.
11. All activities financed from the funds shall be conducted in accordance with the ideals and objects as stated hereinabove and no discrimination should be made on grounds of religion, caste, creed, sex or political affiliation of the implementing agency or beneficiary.

BOARD OF TRUSTEES

12. The Board of Trustees shall be entitled from time to time to appoint with to without remuneration and on such terms and conditions as they may think proper, to appoint committee as they may think proper to function under the Authority and control of the Trustees for carrying out objects of the Trust of these presents or the

management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of Trust.

13. It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of THESE PRESENT as well as matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the trusts and power of THESE PRESENTS and any such settlement or determination shall be valid, binding and conclusive and shall not be objected to or re-opened upon any ground whatsoever.

14. The Board of Trustees shall have full powers to settle compromise or compound, out of court, all suits, action and other proceedings and to settle all or other proceeding difference of demand and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.

15. The Board of Trustees shall be entitled to purchase or hire or to take on lease any movable or immovable property or properties for the purpose of carrying out the objects of the Trust hereby created.

16. The Trustees may from time to time, at their discretion for the furtherance and carrying out the objects of the Trust of THESE PRESENTS borrow such sum as may be determined by the Board of Trustees from time to time in form and manner thereupon. The Trustee shall, at their discretion, make all such dispositions of the properties movable or immovable forming part of the Trust Fund or any part thereof and enter into such agreements, assurances and things in relation thereto as the Trustees may deem proper for giving security for such loan and interest.

17. All money forming part of the Trust Fund and requiring investment shall be invested in any of the securities authorised by law for investment of Trust Funds

which are permissible under **section 11(5) of the Income-tax Act, 1961** or shall at their discretion sell and /or realise the same or any part thereof.

18. All money forming part of the Trust Fund requiring investments shall be invested and the conveyance of assurance in respect of any immovable property/properties forming part of the Trust Fund shall be obtained in the name/names of the Trustees for time being of the Board of Trustees.

BANK ACCOUNT

19. The Board of Trustees of the trust may open any bank account or accounts with such scheduled bank as may from time to time be determined by the trustees and shall forthwith pay or cause to be paid the rents, income, dividends and all other money forming part of the Trust Fund to the credit of any such bank account or accounts. The Trustees shall operate upon the Bank account or accounts or other persons as may from time to time be authorised to do so by a resolution of the Board of Trustees. The Bank account may also be opened in the name of trust or in the name of any institution or projects established by the trust. The managing trustee is authorised by the Board to operate the Account of the Trust.

ACCOUNTS & AUDIT

20. The Trustees shall maintain regular Books of account of the trust funds and shall a chartered accountant or firm of chartered accountants duly audit the same. The Accounts and Audit Report and report of the Trust shall be made-up at least once in a year covering the accounting period as may be determined by the Board of Trustees from time to time.

MANAGING TRUSTEE

21. **Mr.T.Sasikumar** shall be the First Managing Trustee of this trust and shall hold office up to his life time or until he the board of Trustees shall choose other as managing trustee or he resigns or if the Board selects an authorised successor.

22 All the trustees who are for the time being and from time in the office shall be referred to collectively as Board of trustees.

23. A trustee must be an individual and no such corporate body such as limited company, firm, society and Trust shall be appointed as a Trustee of the trust.

DISQUALIFICATION OF TRUSTEES

24. No person shall hold or continue to hold office or be appointed, as trustee on the Trustees office shall be vacated ipsofacto.

- a). If he is found to be or becomes a person of unsound mind,
- b). If he is committed of an offence involving moral turpitude,
- c). If he is adjudged insolvent,
- d). If he is or becomes deaf-mute,
- e). If he is in the opinion of a majority of his co-trustees after an enquiry caused to be conducted by them found guilty of breach of Trust gross negligence or dereliction of duty or
- f). If he is otherwise disqualified to act according to law to which he is a subject for the time being in force.

25. The receipts in writing by the Managing Trustee or any other person authorised by the Board of Trustees for any interest, dividend or income of the Trust Fund or for any deeds, papers, writing documents or other monies and effect payable to the Trustees shall be sufficient and effectual discharge for the same. Trustees by a resolution may also authorise any scheduled bank or other banks in India to collect any interest, dividend or income of the Trust Fund on their behalf.

26. The Trustees shall be at liberty to allow or to be allowed and permit, or to be permitted to amalgamate or to be amalgamated with any other Trust, Institution or Charity, in any areas whose objects are the same or similar to those of THESE PRESENTS, PROVIDED, they are not inconsistent with or repugnant to the objects hereof.

27. The trustees shall have power to buy, acquire, and take on lease any property, movable and immovable that maybe needed to carry out and further the objects of the Trust and incur all such expenses connected therewith.

28. The administration, direction, management of several institutions and establishment in terms of the Trust hereby created shall subject to the supervision, control and direction of the board be with the managing Trustee. In the event of any differences of opinion, the managing trustee shall be bound by the decision of the majority of the board.

POWER TO ALTER RULES AND REGULATIONS

29. If in the opinion of the Trustees, circumstances so require, the Trustees may unanimously make any amendment in the rules, they may consider necessary for the better management or administration of the Trust activities or for carrying out the objects of the Trust.

30. In addition to the aforesaid rules, the Trustees, shall from time to time, be entitled to make rules and regulations for the administration and management of the Trust of THESE PRESENTS and all matters incidental to or concerning the same PROVIDED, such rules and regulations shall not be repugnant to or be inconsistent with the provisions of the purposes of the Trust thereof.

AREA OF OPERATION

31. The area of operation of the activities of "PSYEC Alumni Association TRUST" shall be only with in India and its Union Territories and not outside India.

APPLICATION OF INCOME AND TRUST FUND

32. The Trustee or Trustees shall make investments of the Trust funds in accordance with the provisions of **section 11 (5) read with section 13 (1) (d)** of the income tax Act, 1961 and rules made there under from time to time.

33. The Accounts of the Trust shall be prepared for the financial year commencing from 1st April and ending 31st March.

AMENDMENT CLAUSE

34. The Trustee or trustees can change the objects of the Trust. The change is any way should not be inconsistent with the basic objects of the Trust and are not repugnant to the provisions of **Section 2 (15), 11, 12, 13 and 80G of the Income Tax Act, 1961**. The changes can be done only after getting prior approval from the Commissioner of Income Tax.

IRREVOCABILITY

35. It is hereby expressly declared that the trust is a Public Charitable trust and it is irrevocable at any time or under any circumstances.

UTILIZATION

36 .The Income of the trust shall be utilized for the objects of the trust and no portion of the income of the trust shall be utilized for any other purposes.

DISSOLUTION

37. In case of Winding up of the trust , the net funds shall be disposed to such trust or Approved Institution which are having similar objects and enjoying exemptions under **sections 2 (15),11,12,13 and 80G of the Income Tax Act,1961.**

38. The benefits of the trust shall be open to all irrespective of the caste, creed or religion.

39. The trustees for the time being of THESE PRESENTS, shall be chargeable only for such monies, stocks, funds, deposits and securities as they shall actually receive, notwithstanding their signing of any receipt for the sake of conformity and shall be answerable or accountable only for their own acts, receipts, neglects, defaults, and not for those of others or any banker, auctioneer or any other persons with whom or into whose hands any trust monies or securities may be deposited in accordance with THESE PRESENTS nor for the determination or loss of any stocks, funds, deposits or securities nor for any defects or insufficiency of title nor for any other losses unless the same shall happen through their own neglect or willful demeanor.

40. Proper books of accounts shall be kept by the trustees and the said books of accounts and all letters, documents belonging to the trust shall be kept at the Office of the Trust and at all time open to inspection by the Trustees who shall be entitled to take extracts and copies of the same.

41. The Trustees hereto agree to have bank accounts in the name of the Trust and to raise funds or obtain credits from banks and/or individual and/or anybody by way of deposit, loan, overdraft and shall charge the properties of the Trust for the payment thereof for the purpose of the Trust. The Bank accounts opened in the name of the trust shall be operated by the **Managing trustee of the "PSYEC Alumni Association TRUST"** individually. The documents relating to the loan agreements shall be executed by the Managing trustee.

REMUNERATION TO THE TRUSTEES

42. Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by own negligence and also every Trustee shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.

PROCEEDING OF THE TRUST

45. Any defect in the constitution of the Trust shall not invalidate its proceedings.

RESIDUARY

46. For matters not provided for in these presents, the provisions of the Indian Trust Act and the Income Tax Act, 1961 and rules made there under will apply accordingly.

47. The Trust do not have any assets as on date other than the above mentioned Rs.1001/- (Rupees One thousand and one only). At present time movable or immovable Property is Nil.






