**Amendment:** This MOU may be amended, modified or supplemented by mutual agreement of both parties.

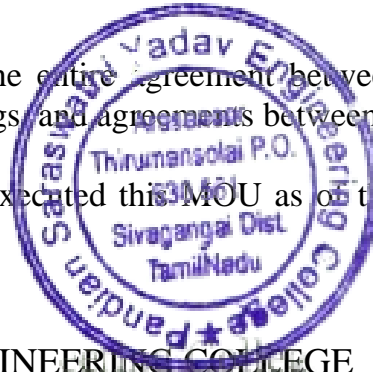
**Governing Law:** This MOU shall be governed by and construed in accordance with the laws of Tamilnadu/India.
