Internship Opportunities: MACADEMY OF MKUBE will provide internship opportunities to PSYEC students in civil engineering.



Termination: Either party may terminate this MOU at any time, with or without cause, upon providing 30 days written notice to the other party.

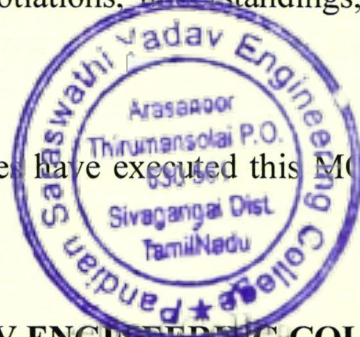



Amendment: This MOU may be amended, modified or supplemented by mutual agreement of both parties.

Entire Agreement: This MOU constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, and agreements between the parties.


